## **Biography of David McInnes**

Among published articles on consumer protection and self-regulation, David has published the book *Taking It to the Hill: the Complete Guide to Appearing Before Parliamentary Committees* (2nd edition, University of Ottawa Press, 2006). He has been an Associate with the University of Ottawa's Centre on Governance and is a graduate of the London School of Economics (Master of Science, Politics and Government) and Dalhousie University (B.A., Political Science).
