










CAPI's second annual Exchange Conference brought together more than 200 agri-food leaders to network, collaborate and advance policy solutions in Ottawa, Ontario. Following the conference, 95% of attendees indicated they would recommend it to their network.



In 2024-2025, CAPI partnered with RealAgriculture on the Ag Policy Connection podcast to develop a six-part series on the future of Canadian farmland and land use policy as part of CAPI's PLAN initiative.

CAPI's PLAN initiative brought together research, reports and tools on agricultural land use. CAPI held multiple PLAN Policy Network Meetings, bringing together stakeholders focused on improving Canada's agriculture land use policies. These meetings provide a forum for voices across the sector to share insights, and forge a path ahead.



CAPI's regular webinars promote dialogue between researchers, partners and stakeholders on a variety of critical topics. In 2024, webinar partners included RealAgriculture, CCFI and GIFS.



CAPI continues to grow its online audience on social media, with a combined audience of 6.5k followers on LinkedIn and X. Over the past year, CAPI's content was shown almost 136k times on these platforms.



CAPI continues to focus on addressing how policy issues impact the agri-food sector through its Policy Pop-Ups series. CAPI published 28 one-minute Policy Pop-Ups on a range of topics, which were shared on YouTube, LinkedIn, X and in The CAPI Connection.



The monthly CAPI Connection enewsletter is an important tool for connecting with CAPI's community online, with an audience of almost 5.2k subscribers.
